DATE: September 20, 2021 TO: HSO Musicians; cc AFM Local 400 FROM: Steve Collins, Executive Director RE: Fall Opening Updates

The purpose of this memo is to provide updates on fall season-opening plans, beginning with our first Masterworks concerts on October 1-3 at The Bushnell's Belding Theater. While there will be some overlap with concepts covered in this memo and the October Executive Director's Report, (to be distributed on or about October 12), I wanted to provide this information prior to the season opening. As always, feel free to reach out to me or any member of our administrative team for further information or to share your thoughts on how we can work together to make the 2021-22 season as successful as possible.

General Season Programming Strategy

With The Bushnell Performing Arts Center and most, if not all, other area performing arts venues open for business, as well as workable federal, state and local health safety mandates in place, the HSO will strive to present a full season of concerts and events – with some caveats. Obviously, if the public health situation changes for the worse and venue restrictions or closures are put in place, concert and event restructuring and/or cancellations may be considered.

All nine Masterworks, three Sunday Serenades, and two Intermix concert programs are scheduled or in process, guest artists hired, etc. Pops concerts have been adjusted to account for a very heavy reliance on single tickets sales, (as opposed to subscriptions), and rapidly changing venue health and safety protocols throughout August and earlier this month. The decision was made to delay a planned Tribute to Aretha Franklin concert from October 2021 to June 2, 2022 and limit the number of Pops concert programs to three instead of our usual four. There is the possibility of adding a fourth program later in the season, but difficult to execute with very busy venue and orchestra calendars in the spring months, and the Talcott festival occupying the summer season.

Additionally, there is considerable concern that audience vaccination and testing requirements may have a substantial impact on family audiences at the December Holiday Cirque concerts. We will keep a close eye on early ticket sales and create back up plans in the event the Cirque program is not a financially viable production this season.

***The orchestra's "winter season" begins September 27th and the previous season furloughs are no longer in effect.

Health Safety Protocols

Orchestra Protocols for Rehearsals and Concerts

Discussions with the Player Safety Committee have occurred throughout the summer months and continue. The principal protocols proposed by management and discussed with the committee are the following. Keep in

mind there are additional line items and many details to be considered. We await a response to our September 8th proposal.

- Vaccine mandate for all musicians, with testing required for those with an exemption for a medical condition or a closely held religious belief, or those who decline to provide vaccination status. (This is required by The Bushnell.)
- Alternate work may be available for any rostered HSO musician who is either unvaccinated or declines to provide vaccination status. Musicians may also make use of the leave of absence policy for a full or partial season.
- Masks are required for all musicians at all times indoors. Wind and brass players may remove masks to play when in a designated performance area.
- String players will sit two to a stand, wind and brass players will be distanced to the greatest extent possible and in consultation with the Music Director.
- All conductors and guest artists will follow the same protocols.

Audience Protocols at The Bushnell

With the season launching October 1st, health safety protocols at The Bushnell for concerts and events are in place and are being tested by Bushnell staff with several "preview" events. All audiences need to provide proof of vaccination or test negative to enter the building and wear a mask while inside except while eating or drinking. Attendance Protocols at Board and Committee Meetings

For Board and committee meetings, and the Annual Meeting on 10/26/21 at the Mark Twain House, proof of vaccination will need to be provided and masks worn in most cases. Details are being finalized and a separate memo will be distributed shortly. Zoom remains available for all committee meetings in the coming weeks.

Strategic Planning Work

Following the June 22nd Board meeting the focus of this work has been on implementing the key strategies in each administrative team member's season workplan, and advancing financial analysis and planning work to address our persistent operational deficits. There are key meetings of the Finance Committee and Executive Committee on September 21st and 23rd, as well as close collaboration with our planning consultant, Joe Kluger. This work will help set the agenda for our October 13th Board meeting to drill down into planning progress and identify next steps.
